ENTERPRISE AGREEMENT.

1. PARTIES TO THE AGREEMENT

This Enterprise Agreement is made in accordance with the Industrial Relations Act 1991. It is entered into on 1st June, 1992 between employer KERMIF PTY LTD of 28 Smith Street, Charlestown, of the one part, and not less than 65% of the following employees - medical receptionists, employed at 28 Smith Street, Charlestown, of the other part.

It is hereby agreed as follows that:

a receptionist may be employed for, and duly paid for, a number of hours less than four but no fewer than two, at any one session worked out of ordinary hours.

2. TITLE OF THE AGREEMENT.

This agreement shall be known as :

KERMIF PTY LTD ENTERPRISE AGREEMENT.

3. INTENTION.

This agreement shall only apply to casual employees in the occupations identified, situated at 28 Smith Street, Charlestown, and relates to hours worked by those staff out of ordinary hours.

4. DURESS.

This agreement was not entered into under duress by any party to it.

5. INCIDENCE.

This agreement shall regulate partially the terms and conditions of employment previously regulated by the Clerks State Award. Apart from the clause specified in this Agreement all other clauses of the award will apply.

6. DATE AND PERIOD OF OPERATION.

This Agreement shall operate from the date of registration and shall remain in force for a period of three years unless varied or terminated earlier by provisions stated in Section 136 of the above mentioned Act.

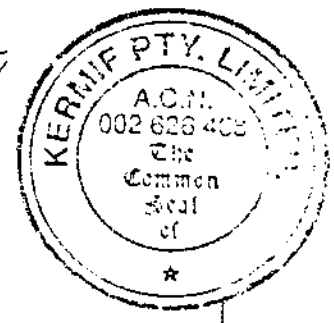
