## **THE THOMPSON'S BAKERY SHOP EMPLOYEES ENTERPRISE AGREEMENT.**

### **1. PARTIES TO THE AGREEMENT**

An enterprise agreement, made in pursuance of the NSW Industrial Relations Act 1991 in accordance with the provisions of sections 115 - 142 of the said Act, entered into between Ben Tan P/L trading as Thompson's Bakery on the one part and its employees covered by the Shop Employees (State) Award on the other.

It is agreed by the parties as follows:

### **2. TITLE OF AGREEMENT**

This agreement shall be known as the Thompson's Bakery Shop Employees Enterprise Agreement.

### **3. INTENTION**

This agreement shall only apply to shop employees situated at the following locations:- Shop 3C Market Place, Maitland NSW 2326 and Shop 5A Wallsend Plaza, Wallsend NSW 2287.

### **4. DURESS**

This agreement was not entered into under duress by any party to it.

### **5. INCIDENCE**

The agreement shall regulate partially the terms and conditions of employment previously regulated by the Shop Employees (State) Award.

Apart from clauses specified in this agreement all other clauses of that Award shall apply.

### **6. OVERTIME**

The clause relating to OVERTIME in the Award is varied in the following respect:-  
The rate paid for all overtime shall be the ordinary time rate.

### **7. TERM**

This agreement shall operate from the date of registration and shall remain in force for a period of three years unless varied or terminated earlier by the provisions provided by the Act.

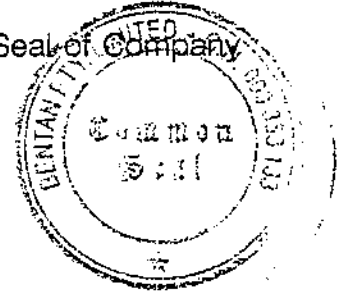
