RAINBOW COTTAGE ENTERPRISE AGREEMENT.

(A) PARTIES TO THE AGREEMENT.

An Enterprise Agreement, made in pursuance of the NSW Industrial Relations Act 1991 in accordance with the provisions of sections 115-142 of the said Act, is entered into between

(1) Rainbow Cottage Occasional Child Care Centre of 134 Marius Street, Tamworth NSW 2340 of the one part and:

(2) The Works Committee of Rainbow Cottage Occasional Child Care Centre in the following workplace; Rainbow Cottage O.C.C.C., with the Casual Employees, of the following occupation; Casual Child Care workers, employed under the 'Miscellaneous Workers - Kindergarten & Child Care Centres' (State) Award, of the other part.

It is agreed by the parties as follows:

TITLE OF AGREEMENT.

This Agreement shall be known as the "Rainbow Cottage Enterprise Agreement".

(B) INTENTION.

This Agreement shall only apply to casual employees in the Occupation identified, situated at the following locations:-

Rainbow Cottage Occasional Child Care Centre,
134 Marius Street, Tamworth, NSW. 2340.

(C) DURESS.

This Agreement was not entered into under duress by any party to it.

(D) INCIDENCE.

The Agreement shall regulate partially the terms and conditions of employment previously regulated by the Miscellaneous Workers - Kindergarten & Child Care Centres State Award.

(E) HOURS OF WORK.

Casual Child Care Workers, employed under the above mentioned State Award, have a minimum starting time of two (2) hours.

Apart from the clause specified above in this Agreement, all other clauses of the above mentioned Award shall apply.

(F) TERM.

This Agreement shall operate from the date of registration and shall remain in force for a period of three (3) years unless varied or terminated earlier by the provisions provided by the Act.
