ENTERPRISE AGREEMENT**

**1. PARTIES TO THE AGREEMENT**

An enterprise agreement, made in pursuance of the NSW Industrial Relations Act 1991 in accordance with the provisions of sections 115 - 142 of the said Act, entered into between the Board of Management, Elizabeth Chifley Memorial Pre-School of George Street, Bathurst, of the one hand and the employee's of the Board of Management, Elizabeth Chifley Memorial Pre-School in the Pre-School with the following occupation : Casual Clerical Assistant of the other part.

It is agreed by the parties as follows :

**2. TITLE OF AGREEMENT**

This agreement shall be known as the Elizabeth Chifley Memorial Pre-School Enterprise Agreement.

**3. INTENTION**

This agreement shall only apply to employees in the occupations identified, situated at the Elizabeth Chifley Memorial Pre-School, George Street, Bathurst.


**4. DURESS**

This agreement was not entered into under duress by any party to it.

**5. INCIDENCE**

The agreement shall regulate partially the terms and conditions of employment previously regulated by the Clerks State Award.

Apart from clauses specified in this agreement all other clauses of the Clerks State Award shall apply.



6. ENTERPRISE AGREEMENT  
Ordinary Hours Of Employment

The hours of employment shall be as follows:

- A minimum of two(2) hours per day of employment.
- Extra hours as approved by the Director or acting Director of the Pre-School up to a maximum of forty(40) hours per week.

Rates of Wages

All hours worked shall be paid the Casual flat rate as per the Clerks State Award, Grade 3. This rate includes any extra hours worked.

7. TERM

This agreement shall operate from the date of registration and shall remain in force for a period of three(3) years unless varied or terminated earlier by the provisions provided by the Act.
