1. Parties to the Agreement

This Agreement is made between Jewel Food Store Pty Ltd and the Shop, Distributive & Allied Employees Association New South Wales to vary the enterprise agreement no.EA 308 of 1995 in the terms of clause 33 - Area, Incidence and Duration. All other clauses remain unchanged.

2. Schedule of Variation

Delete sub-clause (a) of Clause 33 - Area, Incidence & Duration, and insert the following:-

33. AREA, INCIDENCE AND DURATION

(a) This Agreement is made between Jewel Food Stores Pty. Limited, 52 Hill Street, Lidcombe NSW and the Shop Distributive & Allied Employees' Association, New South Wales Branch and the Shop Assistants and Warehouse Employees Federation of Australia, Newcastle and Northern, New South Wales, and applies to all employees and all their conditions of employment employed by the Company within their retail outlets listed below and to the extent that it is inconsistent with any other award or agreement this Agreement shall prevail.




