GREYTON PTY LIMITED ENTERPRISE AGREEMENT

1. Title of Agreement

The title of this agreement is the Greyton Pty Limited Enterprise Agreement.

2. Parties to the Agreement

The enterprise agreement is made in accordance with Sections 115-145 of the Industrial Relations Act 1991 (NSW). The Parties to the above agreement are:

and



3. The Enterprise

The Enterprise for which the agreement was made is Greyton Pty Limited, a specialist construction company, located at 1 Jeanette Street, East Ryde, in the State of New South Wales 2113, covering this and all sites at which employees may be located.

4. Trades or Occupations

The trade/occupation covered by this agreement is carpentry.



5. Intention

This agreement shall only apply to employees in the carpentry trade working out of the office situated at 1 Jeanette Street, East Ryde, in the State of New South Wales 2113.

6. Duress

This agreement was not entered into under duress by any party to it.

7. Incidence

This agreement shall regulate partially the terms and conditions of employment previously regulated by the Building Tradesman State Construction Award:

Apart from the clauses specified in this agreement all other clauses of the abovementioned Award shall apply.

8. Term

This agreement shall operate from the date of registration and shall remain in force for a period of 12 months unless varied or terminated earlier by the provisions provided by the **Industrial Relations Act 1991**.

9. Contents of Agreement

i) Carpenters

The employees employed casually as Carpenters agree to be paid at the following rates:


- Level 1 (No supervisory duties) \$ 18 per hour
- Level 2 (Supervising up to 4 people) \$ 20 per hour
- Level 3 (Supervising more than 4 people) \$ 22 per hour


The employees employed as full time Carpenters agree to be paid according to the rates specified in the Building Tradesman State Construction Award.


